STUDENT PERSPECTIVE

I undertook the Masters in Clinical Pharmacy at UCC at a time in my career that seemed to invite a return to the tenets of clinical pharmacy and when I had an appetite to see what other pharmacists were achieving throughout the world in terms of improving pharmacy services.
